

The regular monthly meeting of the Liberty Township Board of Supervisors was called to order on July 5, 2018 at 7 p.m. Present were Doug Sivers, Alton Wilber, Dave Bailey, Wayne Doc Luce, Clifford Reed, Bill Bayne, Lori Raub, Lennie Kalechitz, Mary Jane Bolles, and Linda Rockwell.

Pledge of Allegiance was said.

Public Comments None.

Minutes Dave made a motion to accept the June 2018 meeting minutes as presented. Alton seconded and Doug voted yes.

Road Report Dave reported the following June activities: grade, rake & roll Buck, English, Cross, Lyon, Upper Rhiney, Lower Rhiney, Howard Hill, Shadowbrook, and Cabin. Dust control was on Buck, Mucky, Stateline, Upper Rhiney, Cross, Lyon, Lower Rhiney, Howard Hill and Camp.

Treasurer's Report Dave made a motion to accept the June 2018 Treasurer's Report, pay Bill List 07-18, pay any bills which are normally paid during the month, and pay the payroll for July. Alton seconded and Doug voted yes.

Scheduled Public Input None.

Old Business Alton noted that the supervisors needed to get a few estimates on the old Grange Hall to cut off the old bell tower, install a new roof. He noted that painting is usually done by a separate outfit. A brief discussion took place on possible uses including township meetings. Lori Raub noted that the supervisors need to look at the total cost—is it worth saving?—is the foundation good? She noted that sometimes it is better to raise a building and start over as costs could be phenomenal with repairs. Alton made a motion to get estimates for repairs, cut off the bell tower, and new roof. Dave seconded and Doug voted yes. It was discussed that a newspaper ad be placed to have prospective vendors stop in the township building for estimates. Linda noted the supervisors should write what they want the ad to say, and she will run it.

New Business Bill Bayne stated that the County Planning Commission subdivision is grandfathered in, but the township's subdivision is not. He was specifically talking about Martin's who had a fire. Lori Raub stated she had attended a class recently and the attorney said the County is not grandfathered in. The County Ordinance states that if a building is destroyed by flood or fire, it can only add a certain percentage. Alton told Bill that he should attend the township planning commission meeting to discuss this. Lori also noted that if they don't bring what is needed, the planning commission can do nothing.

Meetings The supervisors coordinated their calendars to attend upcoming meetings. Doug noted that he will be out of town for the next three weeks.
