

The regular monthly meeting of the Liberty Township Supervisors was called to order by Supervisor Lori Raub on February 6th, 2025 at 7:00 pm. Supervisors Present: Lori Raub & Darin DeRose. Pledge of Allegiance was said. A moment of silence was observed in remembrance/honor of supervisor Alton Wilber, who passed away in January.

Lori made the motion to appoint Stephen Roe as supervisor, Darin seconded the motion.
